

Terms and Conditions of Service for BloomTV

Welcome to BloomTV! These Terms and Conditions of Service ("Terms") govern your use of BloomTV's streaming TV network and related services (collectively, the "Service"). Updated on June 6, 2023. By accessing or using the Service, you agree to be bound by these Terms. Please read them carefully before using the Service.

Acceptance of Terms

1.1 By accessing or using the Service, you represent and warrant that you have read, understood, and agree to be bound by these Terms. If you do not agree to these Terms, you may not access or use the Service.

Description of Service

2.1 BloomTV is a streaming TV network that provides users with access to a variety of digital content, including but not limited to, TV shows, movies, documentaries, and other audiovisual content ("Content"). The Content may include works produced by approved creators who have granted BloomTV the right to host their content, as well as exclusive content owned by BloomTV.

2.2 BloomTV reserves the right to change, suspend, or discontinue the Service, or any part thereof, at any time without prior notice or liability.

Account Creation and Usage

3.1 In order to access and use the Service, you must create an account ("Account"). You agree to provide accurate, current, and complete information during the registration process and to keep your Account information up to date.

3.2 You are solely responsible for maintaining the confidentiality of your Account login credentials and for all activities that occur under your Account. You agree to notify BloomTV immediately of any unauthorized use of your Account or any other breach of security.

Content Ownership and Licensing

4.1 Some of the Content available on the Service may belong to approved creators who have granted BloomTV the right to host their content ("Approved Content"). Other content available on the Service may be the exclusive property of BloomTV ("Exclusive Content").

4.2 You acknowledge and agree that BloomTV retains all rights, title, and interest in and to the Service, including the Content. You may only access and view the Content for personal, non-commercial purposes in compliance with these Terms.

4.3 You may not reproduce, distribute, modify, transmit, perform, display, or create derivative works from any part of the Service or the Content unless expressly authorized by BloomTV or the applicable rights holder.

Cancellation Policy

5.1 If you wish to cancel your Account, you must either manually cancel your Account through the Service's account settings or contact BloomTV via email to cancel your Account within five (5) business days before your next billing period.

5.2 In order to avoid being charged for the next billing cycle, you must cancel your Account as described in section 5.1. Failure to cancel your Account within the specified timeframe will result in the non-refundable payment for the next billing cycle.
